# Ward report – Old Gore Ward July 2016

### One Herefordshire programme

The One Herefordshire programme will enable a system wide strategic direction and delivery mechanism to deliver the Health and Wellbeing Strategy and the Children and Young People's Plan. In turn, this will drive improved wellbeing, co-ordinating activities across the council and its health and VCS partners. It will enable the council to engage with wider public sector partners in a co-ordinated manner to increase efficiency and value for money. By exploring joint commissioning arrangements with the CCG this represents an opportunity to improve the efficiency and impact of the council's commissioning function alongside that of the NHS, to provider better value for money.

The Sustainability and Transformation programme (STP) process is intended to provide the central vehicle through which local government and the NHS can work together in order to achieve the 'triple aim' of improving the health and wellbeing of the local population, improving the quality and safety of care delivery and securing ongoing financial sustainability.

It is expected that the STP process will be merged with the requirement, flagged by the then Chancellor of the Exchequer in October 2015, for all areas in the country to produce a plan for the full integration of health and social care by 2020. Guidance on this process is expected to be published jointly by the Department of Health and the Department for Communities and Local Government during the autumn, with plans to be prepared by the end of the financial year.

# Understanding Herefordshire: the joint strategic needs assessment (JSNA) 2016

Herefordshire Council and the Herefordshire Clinical Commissioning Group (CCG) have joint duties in regard to the JSNA, but the development of Herefordshire's JSNA is a statutory function of the health and wellbeing board. The JSNA directly informs the development of the health and wellbeing strategy.

It describes the local community's current and future health, independence and wellbeing needs. It is a high level needs assessment that provides local commissioners with a wealth of data that clearly describes the key issues for the local population. Provides information to enable commissioners to set strategic priorities and make decisions for service delivery and redesign.
